



EPS Liability Release Waiver

The World Health Organisation has declared the novel Coronavirus (**COVID-19**) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the Government has set recommendations, guidelines, and some prohibitions to which Edinburgh Photographic Society (the "Society") will comply.

In consideration of the current situation, the undersigned acknowledges and agrees to the following:

- I am aware of the existence of the risks arising from my presence in the EPS Studio and my participation in Society Studio activities that may cause injury or illness such as, but not limited to Influenza or COVID-19 that may lead to severe illness or death.
- I have not experienced any of the symptoms associated with COVID-19 as advised by The Scottish Government (<https://www.gov.scot/news/update-to-coronavirus-symptoms/>), which may include but are not limited to: fever, loss of sense of smell or taste, difficulty in breathing and/or dry cough.
- I have not exhibited any other symptoms relating to any other communicable disease within the last 14 days.
- I am not currently required to quarantine myself due Scottish or UK government regulations or advice.
- I have not been, nor has any member(s) of my household, diagnosed to be infected with COVID-19 virus within the last 14 days.

Following the pronouncements above I hereby declare that:

I have read and understood the 'Risk Assessment for Photographers & Models' and agree to implement the control measures allocated to "Studio Users"

I have read and understood the "Studio Access Rules" and agree to abide by them at all times.

I am fully and personally responsible for my own safety and actions while and during my participation and I recognise that I may be, in any case, at risk of contracting COVID-19.

With full knowledge of the risks involved, I hereby release, waive, discharge the Society, its President, its Trustees, Council, Members, independent contractors, affiliates, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me related to COVID-19 while participating in any activity while in, on, or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19.

I agree to indemnify the Society from and against any and all costs, expenses, damages, lawsuits, and/or liabilities or claims arising whether directly or indirectly from or related to any and all claims made by or against any of the released party due to injury, loss, or death from or related to COVID-19.



By signing below I acknowledge that I have read the foregoing Liability Release Waiver and understand its contents; that I am at least eighteen (18) years old and fully competent to give my consent; that I have been sufficiently informed of the risks involved and give my voluntary consent in signing it as my own free act and deed; that I give my voluntary consent in signing this Liability Release Waiver as my own free act and deed with full intention to be bound by the same, and free from any inducement or representation.

This waiver will remain effective until amended by EPS Council.
